

IMPORTANT DATES & INFORMATION

FALL 2010

First day of Day & Evening Classes.....August 23, 2010

Last day to drop 100% refund 16 weeks classes.....August 30, 2010

First day of Late Start Classes .....September 7, 2010

Last day to Drop 100% refund Late Start classes.....September 14, 2010

Last day to withdraw 1<sup>st</sup> 8 week classes..... October 1, 2010

2<sup>nd</sup> session 8 week classes.....October 18, 2010

Last Date to drop 100% refund 2<sup>nd</sup> 8 week classes .....October 25, 2010

Last day to withdraw 16 week classes.....November 24, 2010

BEFORE WITHDRAWING from all classes a student must contact the Financial Aid Office, as the student will be responsible for part or all items applied against their financial aid funds.

\*FINANCIAL AID DOES NOT PAY FOR SCHEDULE CHANGE (DROP) IN WHICH \$25 DROP FEE is charged.

Note: Should you drop or be dropped (failure to attend classes) your Pell funds can result in the following:

1. Award will be reduced
2. Not eligible for a refund check
3. Billed for classes in which you fail to attend

2<sup>nd</sup> 8 week classes begins.....October 28, 2010

Please NOTE deadline date for purchasing books, supplies, bus passes and etc., are NOT available for 2<sup>nd</sup> 8 week classes.

**Also students that drop and/or add classes will delay Pell checks.**

**1<sup>st</sup> Disbursement Pell check date .....Week ending October 26, 2010**

Your completed financial aid file including all documentation requested must be in the Financial Aid Office by October 4, 2010 for the 1<sup>st</sup> disbursement date.

**ALL PELL GRANT CHECKS ARE MAILED TO THE STUDENT'S RESIDENCE, STUDENTS CANNOT PICK UP CHECKS**

2<sup>nd</sup> Disbursement Pell check date.....Week ending December 6, 2010

Your completed financial aid file including all documentation requested must be in the Financial Aid Office by November 22, 2010 for the 2<sup>nd</sup> disbursement date.

For any missing documentation, your financial aid is considered pending and not complete. An incomplete file will delay any refund and can result in the removal of all financial aid funds. Requested documents must be submitted within 7 business days. You will be contacted by your SSC E-Mail account. Please check your correspondence regularly.

**WARNING: Any unpaid obligations such as unpaid drop fees, traffic fines, library fines and etc., will stop disbursement of any monies until the fees have been paid. A check will not be issued until the next disbursement Pell check date.**
